CONTRACT TERM
This agreement establishes a six (6) month advertising commitment between Team Digital Network ("TDN") and the advertiser identified above ("Advertiser"). The six-month term begins on the advertising start date identified on the applicable Advertising Agreement and continues for six (6) consecutive months. The specific advertising location(s), advertising services, start date, end date, billing arrangement, and other campaign details will be identified on the applicable Advertising Agreement. The Advertiser acknowledges that the Advertising Agreement and this 6-Month Advertising Contract are intended to be read together. Six-Month Commitment By signing this contract, the Advertiser agrees to maintain the advertising services selected on the Advertising Agreement for the full six-month term, allowing Team Digital Network to reserve the Advertiser's placement for that period. Early Cancellation The Advertiser is committing to the full six-month term. If the Advertiser requests cancellation before the end of the six-month term and Team Digital Network agrees to the early cancellation, the Advertiser will be responsible for an early termination charge equal to 50% of the remaining value of the contract. If Team Digital Network terminates the agreement because of non-payment, the Advertiser will also be responsible for 50% of the remaining value of the contract. Any amounts already invoiced or owing prior to termination remain payable.

TERMS & CONDITIONS

1. Advertising Agreement

This contract works together with the applicable Advertising Agreement, which identifies the advertising services selected by the Advertiser.

2. Contract Period

The contract remains in effect for six consecutive months beginning on the start date shown on the Advertising Agreement.

3. Advertising Content

The Advertiser is responsible for all supplied content and confirms they have the right to use all materials provided to Team Digital Network.

4. Advertisement Approval

Team Digital Network may reject or request changes to advertising that is unlawful, misleading, offensive, inappropriate, or unsuitable for the location.

5. Advertisement Changes

Replacement advertisements may be submitted during the contract. Work outside the agreed advertising services may require separate approval.

6. Display Availability

Temporary interruptions may occur due to equipment failure, power or network outages, maintenance, property-owner requirements, or circumstances beyond Team Digital Network's reasonable control.

7. Service Interruptions

Temporary interruptions do not cancel the contract. Team Digital Network will make reasonable efforts to restore service when reasonably possible.

If a display requires extended repairs, Team Digital Network may move the advertisement to an available display of **equal or lesser value**, with the monthly cost adjusted to the replacement display's current rate.

8. Payment

The Advertiser agrees to follow the billing arrangement established with Team Digital Network. Failure to maintain that arrangement may result in suspension or termination of advertising services.

9. Early Termination

Early cancellation requires Team Digital Network's approval and results in an amount owing equal to **50% of the remaining contract value**. The same applies if the agreement is terminated for non-payment.

10. Changes to the Agreement

Changes to this contract must be agreed to by both parties. Advertising locations or campaign details may be changed through an updated Advertising Agreement.

11. Entire Agreement

This contract and the applicable Advertising Agreement together represent the agreement between Team Digital Network and the Advertiser for the six-month advertising commitment.
